

INTRODUCTION OF SPECIAL GUESTS



Grand Exalted Ruler Brother Potter introduced and turned the Chair over to the Chairman of the National Judiciary Committee, Sister Barbara Evans who presented the Resolutions to the delegates for discussion and debate, commencing with a directive as to the procedures to be followed when dealing with each Resolution.

Recessed 12:00 Noon Sessions reconvened at 1:15 p.m.

As the sessions reconvened, Grand Exalted Ruler Brother Potter asked all first time delegates to a National Convention to stand. There were 15 members present who were applicated as first time attendees.

MEMBER SERVICES COMMITTEE PRESENTATION

Brother Michael Hutchison, Chair of the Member Services Committee was introduced to the delegates. He introduced the Members of the Committee who were in attendance. At this point the Committee members were requested to come forward to proceed with the presentation. The Committee gave an overview of the happenings over the year.

- Lodge requests for funding for events, advertising etc. up 40 to 50% from last year but still only from eight Lodges
- Member Services Committee created an Elevator Speech and had cards printed for handout
- Leadership training trial run at the Alberta Elks Association Conference which allowed for more participants
- Created a partnership with Parts source/Canadian Tire made great strides with Parts Source
- Elktober contest netted 70 new members and plan on running it again only in a different format with Grass Roots membership events

Brother Cory Blair had a shared activity splitting the delegates in groups to defining their values. When team members share the same values it creates a purpose - a shared vision. The groups then had to either create an Ad or draw a picture that described the shared values to resemble the end goal in identifying the Elks values or create an advertisement that they would like the public to see. Once the activity was completed, the groups shared their ideas with everyone. Brother Blair thanked everyone for their participation and hopes that some of these ideas would be taken back and shared with their Lodges.

Brother Hutchison thanked the Presidents for helping with the group activity.

MARKETING COMMITTEE PRESENTATION

Brother Pat Clark, Chair of the Marketing Committee was introduced to the delegates. Brother Clark reported that the Marketing Committee had come up with a special convention promotion - a one of a kind custom made Elks Hockey Jersey. Tickets are \$20.00 each and will be sold throughout Convention, limited to 75 tickets and all proceeds from the raffle will go to the Fund for Children.

Her Honour, the Honourable Judy Foote, Lieutenant Governor of Newfoundland and Labrador, and His Honour Howard Foote upon their arrival were met by Sister Susan Ash, President, NL/Labrador Elks Association and Co-Chair of the Convention Committee and properly introduced to the Delegates by Grand Exalted Ruler, Brother Potter.




She thanked the Gander Elks for the invitation to speak at the National Convention and welcomed everyone to Newfoundland/Labrador and especially in Gander where she is sure that everyone will be treated to great Newfoundland hospitality.



She has heard great things about the Elks organization and knows that the Elks are outstanding volunteers. She thanked the Elks for their public service especially for those with speech and hearing challenges. She was delighted as the 1st female Lieutenant Governor to acknowledge the decision by the Elks of Canada to change the Constitution in 1998 to admit female members in the Order.

She talked about Government House in St. John's belonging to every person in Newfoundland/Labrador and that everyone is invited to tour the grounds. She spoke of the heart garden on the grounds that was built in honour of the Indigenous children who were lost to the residential school system,

to recognize those who survived and for families of both. She also spoke on mental health and wellbeing. In her position as Lieutenant Governor, she considers herself to be a role model for young girls and women and promotes women whenever she can.



Brother Potter then introduced Scott Simms, Member of Parliament. In his opening remarks he said it was a pleasure and an honour to have been asked to speak. Mr. Simms has been a Member of Parliament for fifteen years and prior to joining politics, he was a TV



weather man. He welcomed everyone to Gander. He commented on how Gander had become the center of attention in Canada for all the wrong reasons during the 9-11 crisis. Gander and surrounding communities opened up to the world, the world came to them and when the world left town, we were so much the better for it. When "Come from Away" came out and is now around the world, we are once again the center of attention for all the right reasons.

- exploring new ways to improve communications with the Associations and Lodges

- **AB Brother Darren Scott** last year we decided to relook at our structure, governance, sustainability and relevance. Set up a membership plan with focus on membership retention by having tools to help the Lodges retain 95% of their membership. Membership Retention Plan is on the Alberta Association Web site, as well as Lodge projects.
- **SK Brother Chris Svab** no major projects. We have a few Lodges picking up new members. We are trying to partner with another organization. We never give up.
- **MB Brother Les Walker -** The Manitoba Elks Association sponsors a Children's Camp, Camp Wannakumbac. We have six very active Lodges in the Association. Need to try to find new members and need to come up with some new ideas.
- **ON Brother Randy Vincent** 1st official duty as newly elected President is to attend VOICE camp. Aim is to visit ten of the thirteen Lodges in Ontario. Two key points of focus will be membership and the Fund for Children. We are Elks Proud.

If meetings are too lengthy or uncontrolled, members will not want to come out.

My theme for the year is 'Thanks for Caring'. Everyone who attends meetings, District meetings, Provincial Conferences, Conventions, works fundraisers, sells tickets, etc., CARE! If you did not CARE, you would not be here today.

We have a new elevator speech that was prepared by our Members Services Committee which members are encouraged to use when asked questions like 'Who are the Elks? What do the Elks do? We truly went viral with the idea when a local Saskatchewan farmer and owner of Bulldog Corn Mazes, Brother Chris Scoular of Cutknife Lodge No. 380 paid tribute to the Elks of Canada by creating an Elks of Canada and Elks Proud pattern in his corn field this year. The video we shot showcasing the community corn field as well as many of our members, reaching over 25,000 viewers from every corner of the country and beyond.

We carried that Elks Proud momentum into the year by continuing to take the opportunity to recognize many of our amazing members through the Elks Proud Awards that have now started to circulate across the country to Lodges far and wide. We are sure that many of you have had the pleasure of seeing one of these awards being awarded to a self-less member of our Order and seeing the incredible impact that it has made on them, through a simple peer recognition. We look forward to seeing many more of our members get the recognition that they deserve, and share that feeling of pride on to the next individual that they choose to pay it forward as part of the process.

Our first ever Elktober event was launched in October this year, creating some buzz and excitement about engaging that next generation of Elks Members. In one single month, and with only a handful of Lodges participating, we were able to bring nearly 70 new members into the Order. This was a fantastic start to our Elktober event, and we hope to work with more Lodges to engage more new members in the coming year.

These ideas and newfound initiatives could not be achieved without the work that is being done at the Committee and Grand Lodge level, and this year an effort was made to create more connection between these groups so that ideas and connections could flow across mandates and create wider impact within our organization. In September this year, the Marketing, Charities and Member Services Committees all met as one to discuss possible collaboration opportunities, and many of the initiatives that you have seen over the last year, as well as some new initiatives that you will hear about at Convention this year, are a direct result of that cross collaborative spirit.

The Elks and Royal Purple Fund for Children continues to be the single greatest initiative that binds our Order together. The opportunity for us all to work together and contribute to help a small child in need of hearing aids, speech therapy or adaptive technology is not something that can be matched in our hearts. Our national charity is something that we all show an extreme amount of pride and pleasure from, and continues to change lives from Coast to Coast.

Our Charities Committee, along with our Charities Coordinator Alissa Hill, have done an amazing job of maintaining our core purpose within our charitable practices, and have worked with many members, Lodges and Provincial Associations to raise awareness and further funding models to keep our momentum within our charitable activities both relevant and meaningful. Alissa's enthusiasm and fresh approach to charitable programming has resulted in new ideas and creative approaches in an attempt to engage a new generation of supporters to create a sustainable model for the future. We would continue to encourage you to follow all of our social media pages to see some of the great stories that Alissa is sharing.

We've also seen the work that the Marketing Committee has put in over the past couple of years start to pay off in a larger capacity this past year, with initiatives to engage local communities, families and children in ways that position the Elks of Canada as the fraternal organization of choice within a local and national audience. Charlie the Elk, our

national mascot, has travelled the country making an impact in parades, walks, visits with local schools and participated in Canada Day events, sharing smiles, Elks membership information and Elks branded colouring books for the kids.

The Member Services Committee has also continued to make significant impact on the order, providing guidance and direction in both the external attraction of new members, but also focusing on retaining our existing members, and developing the home-grown talent that exists in our midst so that they can become the next generation of leaders of the Order.

The Alberta Provincial Association also worked with your Member Services Committee to create an elevator pitch for members and developing business cards to share across the Order in the hopes of helping drive membership to local Lodges. These pitches will be shared with members during the sessions this week, and you will also see some of the business cards that they have produced and intend to share across the Order.

Our Grand Lodge Building continues to be a facility that our members can be proud of, and a form of revenue generation for the Order. We've had to make some further renovations to the building which resulted in additional costs over the last year, but have brought the building up to code and given us fresh new bathrooms on both floors that are accessible and bright for tenants and clients alike. Our facility is fully rented, and with one tenant in the process of renewing their lease, will ensure that we remain that way for the next three years.

Brothers and Sisters, our great Order **is in need of your help**. As we continue to decline in membership, our very existence is in jeopardy, and there is a need for some significant and drastic changes to be made in order to not only guarantee our existence for the future, but grow and thrive. We have rested on our laurels for far too long, and we need to work together to build the future of our organization and ensure our sustainability for the future.

Brothers and Sisters, this coming year will be one of tough decisions and reflections for the Order. We will all be required to deeply consider the direction that we are headed, and what our collective appetite is to work towards evolving our great organization to become an open and inclusive fraternal organization that is attractive to the next generation of men and women doing amazing things for their communities, bound together by the ties of a great fraternity which seeks to make life sweeter, people better and the world happier. We cannot simply continue to ignore the very fact that our Order is continuing to reduce in number, and dismiss the idea that it isn't impacting us. We've kicked this discussion of change and revitalization down the tracks for many years now, and to put it bluntly- we are out of track. Our financial reserves are close to being fully depleted, and our membership has not been in a state of positive growth for over 20 years. Something has to change, or our fate is sealed.

The good news is that there are amazing people amongst us, with vision and hope who have proven that our organization can grow and thrive. There are others with ideas and energy that can help us engage a new generation of members and grow our Lodges. But we need to **WANT** to change. We need to **WANT** to allow a new way of thinking and a new way of doing things to prevail. And we need many of our Lodges to make way for a new group of leaders and members, who may not see things the same way we do, take the reins and move us in different directions than we are used to. If we are willing to adapt and change, the Elks of Canada have a chance to not only survive in a future state where other organizations have ceased to exist, but we may also have the opportunity to flourish.

There is now a need to make hard decisions, with real and immediate impact. Our action must be swift and just, and we must have everyone in the Order committing to increase our membership. If each member brought in a minimum of 1 new member this year, that would be wonderful, and would offset the loss of deceased members.

It needs to be understood that if we continue to lose members at the current rate, we will not be around in 5 years... that is the stark truth in the matter.

Your Grand Executive believes that there is a path for the future- the choice of what that future looks like is something that is all members responsibility; it is no longer someone else's responsibility. We all share in the future of our great organization, so let's prove the critics wrong and get our membership numbers up this coming year. Our very existence depends on it.



REPORT OF THE GRAND EXALTED RULER TO THE 2019 GRAND LODGE CONVENTION

Welcome to the "ROCK" and the 107th Annual Convention.

This year has gone by so quickly. It seems like we just got started on the journey last month but it is all over with the windup being in a beautiful city like Gander and the hospitality of our Newfoundland friends. Debi and I want to thank each and every member of the Elks and Royal Purple Elks we had the pleasure of meeting and speaking with. Each visit was unique and special. From Vancouver Island to Newfoundland and Yellowknife we were greeted and treated with enthusiasm and friendship. When we set out we could not have imagined it would be as wonderful as it turned out to be. I was told by Past Grands that it would be a special time but no words can describe the absolute joy it became to us. From the worst thing that could happen to a parent last May when our son passed away and our decision to continue on and the support shown to us by our Elks "family", we have not regretted that decision. Everywhere we went the support and kindness of each and every member of this great Order helped us deal with life. Some 51 visits and 45,000 kilometers later we are finally at the end. Every Lodge we visited could use some help in some way and I wish I was able to stay and help them resolve it. I made notes and phone calls to try to get them what they needed but it is so hard to fix everything.

The main thing I have seen is dwindling membership and Lodges struggling to keep alive. As you will see in this Convention a lot of talk is going to centre around our loss of members. Ladies and Gentlemen, we are in a tough spot. Our communities need us, our National Charity needs us, the hundreds of children we help each year need us. We are needed as much now as we were 50 years ago. What we do is immeasurable and we need more help. If each member was to go out and bring in one new member we could double our membership. Now if everyone could convince 2 to join, we could begin the long hard trek to being the biggest charitable organization in Canada. The Elks in the US are doing it, why not follow that lead. I was able to speak to a group of volunteers at a "Volunteer Appreciation Night" in Gander back in April. I applauded them for being volunteers and asked them how it made them feel to contribute their time. To a person they all said it made them feel good. I explained that becoming a member of a charitable organization you can feel that way every day of the year. I went on to tell them what we do nationally with speech and hearing and not many of them were aware of that, plus all the great things we do in our communities to make it better.

Being a leader and the face of the Elks for a year is something I will cherish for the rest of my life. I spoke with emotion and appealed to the hearts of the members and anyone else who would listen when I had the floor. I think we need to concentrate on revitalizing our current Lodges and make sure they are on steady ground right away as it seems at every GL Executive meeting we are accepting the return of charters 2 and 3 at a time. In some cases we had no idea the Lodge was in trouble. They never asked for help from Grand Lodge and did the Associations know? Folks it is your duty as a member to try to help these Lodges survive or at least bring it to the attention of the Associations or Grand Lodge. I have been in small towns (populations of 100 or so) and they have great memberships. Some have 80 members. Then the medium size towns (3000 or more) are really struggling. Why is that? In the Cities it is even worse. We have very few thriving Lodges in cities. Most have a small membership and are limited to what they can accomplish with those few numbers. I did my absolute best when I was asked to do a radio or newspaper interview. Even had the opportunity to do a TV interview at a small local station in Manitoba.

I was able to visit the BC speech and Hearing Clinic in Surrey and the Central Speech and Hearing Clinic in Winnipeg. I was amazed to hear that the Director at the Central Speech and Hearing Centre takes no wage from the centre. Two

of her children graduated from the program there and she feels obligated to pay back the gift her children received. She speaks very highly of our organization and the whole interior of the centre is covered with Elks signs and such. In BC half the workers there are parents of children who went through the clinic as well. Again they want to pay back the people who helped their children. So folks if you need a quick reminder of the importance of our existence, I ask you to visit these places. ISTAR in Alberta, SPARC in Saskatchewan, VOICE in Ontario, all programs we support through our National Charity. Also the Sask. Elks Assoc. is involved heavily in Senior Housing. They have facilities in several communities in Sask. and provide low income housing to Seniors. Camp Wannakumbac in Manitoba is a place the Manitoba Elks Assoc. sponsor. It is a kids camp and runs programs each year for kids. Lodges in Manitoba sponsor kids to go and it is a very nice facility. We had the Manitoba Conference there and had a great time. So many great things we do but a declining membership is putting all these programs in jeopardy. Diminished attendance at our conferences is showing and we need to get that enthusiasm back. Very few resolutions coming to the floor and very few members making decisions that concern the whole membership. Somehow, someway we need to renew the zeal we once had for the Order and its direction. Everyone here has a desire to see the Order succeed so we need to make a plan, take it home with us, share it with our Lodges, Districts and Associations and start to regrow this Order.

So, Brothers and Sisters I am asking each one of you to take this message home with you and do your best to promote the Order and to increase our membership. It is upon each one of you to deliver the message to your Lodge, your community, and your Association. If we lose the battle there will be a whole lot of people in this country that will be in trouble and no one to help them. Everyone in this room has to take responsibility for their Lodge, District or Association. Together we can survive but if one of you thinks that you have already done your part, that it's someone else's turn, you are mistaken because if you think that and the person next to you thinks that and the person next to them etc etc.. So all I'm asking is each of you find one new member, just one and we will be back on track. Take this challenge back to your Lodge and challenge each member to do the same. We need to stop the bleeding and show a positive increase in membership RIGHT NOW. It has been declining for the last 20 years and has now hit the critical stage. Fix it now or we die.

Sorry if I made this sound horrible. I am an upbeat person. I call myself an "optimistic pessimist" and by that I mean I never get too high on something and that way if things go south I am never devastated. I will live to battle on another day but if the Elks die I may not be able to survive that because you folks have taught me what it is to be a giving person, to bleed purple, to enjoy life and be proud of who I am and what I do. And that is why I consider all of you my "Family".

In closing I want to thank all of you for the opportunity to be the leader of this great Order for this past year and my hope Is that I did you proud and wish Derek and the new Executive all the best.

Worthy Grand Exalted Ruler, Members of the Grand Executive, Brothers and Sisters:

The financial statements of the Grand Lodge of the Elks of Canada, which includes the General Fund and the Elks and Royal Purple Fund for Children, have been audited in accordance with the Constitution on a consolidated basis by our auditors Deloitte LLP. These financial statements together with the accompanying Auditor's Report have been reviewed and approved by the Audit/Finance Committee and the Grand Executive.

The financial statements have been prepared in accordance with Canadian Auditing Standards for not-for-profit organizations except that no provision has been made for amortization of the cost of the Grand Lodge office building and on subsequent additions and improvements. The financial statements are the responsibility of Management, who is responsible for their preparation and fair presentation and for such internal controls as Management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error. Financial information presented in this report is consistent with information in the financial statements.

The Grand Executive, Grand Lodge Committees and Grand Lodge office staff are to be commended for their efforts to work within their budgets during the past year. Unfortunately some revenues were less than expected and some expenses greater than budgeted resulting in a loss greater than that budgeted for the Grand Lodge General Fund, which showed a net loss from operations of \$71,084 compared to a budgeted loss of \$49,035, a difference of \$22,049. The overall net assets of Grand Lodge decreased to \$1,276,433

Grand Lodge 2018-19 Statement of Revenues And Expenses Comparisons

The Elks and Royal Purple Fund for Children showed a net loss of \$15,025 compared to a budgeted profit of \$730, a difference of \$15,755. Although an estate bequest budgeted for \$100,000 was not received for fiscal 2018-19 and other fund raising revenues were \$21,965 less than budgeted, investment income was \$69,390 greater than the amount budgeted. Also fundraising expenses were \$11,029 less than budgeted and program expenses \$26,410 less than amount budgeted.

Grand Lodge Budget

For the fiscal year ending April 30, 2020 we are forecasting for a net deficit of \$20,391 for Grand Lodge. We have summarized some of the revenue and expense items below.

Membership Fees

For 2019-20 we are budgeting for a fee income of \$502,000 compared to actual fees of \$497,382 for fiscal 2018-19. Although we are anticipating a decrease in dues-paying members of up to 400 members the Grand Lodge Executive has approved a per capita raise in membership fees of 5% effective January 1, 2020.

Investment Income

Investment income increased to \$12,974 for fiscal 2018-19 due to a very strong market. Because Grand Lodge investments decreased from \$159,808 to \$97,623 during fiscal 2018-19 we are budgeting for investment income of \$5,000 for 2019-20.

Facilities net Income

Net income from Grand Lodge office building increased by \$8,137 to \$79,626 for fiscal 2018-19. We are budgeting for a small increase to \$80,500 for fiscal 2019-20.

Net Sales

Due to a write-down in value of some old stock net sales decreased to \$10,095 for fiscal 2018-19. We are hoping that sales will improve and have budgeted \$22,500 for fiscal 2019-20.

Operating Expenses

We are budgeting for a modest decrease in operating expenses of \$17,227 for fiscal 2019-20 due to a reduced working arrangement between the Grand Lodge Executive and the Executive Director.

Convention Expenses

We are budgeting for an increase of \$16,290 in convention expenses for fiscal 2019-20 due to the increased travel of the Grand Executive, Committee Chairs and Grand Lodge staff.

Grand Exalted Ruler Expenses

We are budgeting for a decrease of \$11,299 in Grand Exalted Ruler expenses for fiscal 2019-20 due to a \$5,000 reduction for the incoming G.E.R., a reduction in travel to remote areas to zero and a reduction in awards to \$2,700.

Grand Lodge Officer Expenses

We have budgeted \$12,000 for Grand Lodge Officer expenses for fiscal 2019-20 due to a reduction in face to face meetings from two to one.

Lodge/Membership Expenses

Lodge/Membership expenses will be reduced by \$30,685 to \$15,350 for fiscal 2019-20. This is due to leadership training moving from a national level to a piloted cost sharing agreement between Provincial Associations and Grand Lodge.

Lodge Organization and Development

We have budgeted for an increase of \$8,142 in Lodge organization and development expenses for fiscal 2019-20 to accommodate a need to assist struggling Lodges before they are forced to close.

Our sincere thanks to Grand Lodge office staff. They are to be commended for their efforts to administer their duties for the benefit of all members.


In closing, I once again thank the Members of the Member Services Committee for their dedication and contribution to growing our membership. As always, we are here to help and serve the membership.

As many of you are aware, our beloved Charlie the Elk has been making his rounds all across the country. Charlie continues to be a very welcome attraction wherever he goes. Charlie's popularity has encouraged Provincial Associations to explore ordering their own Charlie or mascots that look similar. We have thought about starting Charlie his own social media page to help spread the positive images which follow him.

Mini Charlies have also proven to be popular with sales being sufficient enough to consider placing an order for another batch.



COLOURING BOOK

We are in the process of putting together the 3rd edition of our colouring book "Charlie Takes Flight". Kassidy Kalyniak who was our artist for the second edition has agreed to work with us again. The text and story line are currently being

developed (June) and will be sent off to her. The planned release is mid to late September which should be perfect timing for Lodges interested in doing colouring contests in their areas.

SPECIAL CONVENTION PROMOTION

Just as a fun way to get some attention, the Memberships Committee came up with the idea of developing a very unique item to be raffled off at this years Convention. We thought what's more Canadian then Elks and hockey and so the two were combined. We are offering up a 1 of 1 Elks of Canada hockey jersey. Tickets will be sold at \$20 each throughout Convention and will be limited to only 75 with all proceeds going to the Fund for Children.

LODGE PROMOTION

The Committee felt it important for Lodges to take the time to promote themselves within their communities. Sometimes Lodges do not always know how to go about promoting themselves and/or the Elks in general, therefore they just choose to do nothing at all. The Committee felt that if the Lodges had some guidance in regards to marketing themselves there would be a greater chance of them trying to do so. We decided to develop a comprehensive list of various ways for the Lodges to be recognized in their communities. The list was varied and offered many options because what works in 1 Lodge doesn't always work in another. The original intent of this list was to be put into the form of a mail out to all Lodges pretty much as a refence sheet. Upon submission it was brought to light that Member Services was working on a community involvement/promotion project of their own. The list has been passed on to the Member Services Director for future use in community involvement projects in collaboration with Marketing.

FUTURE PROJECTS

Some ideas that have come up throughout the year that we as a Committee are looking at exploring are as follows:

- setting up a deal for Lodges to purchase pop up tents to be used at events held in their communities. The program would be similar to the one set up a few years back for the pop up banners.
- setting up partnerships with larger store chains to promote the Elks and our FFC in their stores allowing for "round ups" at check out or donations at the till. This is proving to be a difficult task as it is tough to get some thing that works nationally but still trying.
- youth sports sponsorships packages. We talked about the value in sponsoring youth sports or even just hosting a tournament (i.e. baseball). It was thought that if there was an information/instruction package pro vided to the Lodges on how to do it they may be more willing to try it. It was also thought it would be great if we could have all Lodges host or Sponcer an event across Canada on the same day. This would be great for media coverage.
- since its inception the Elks Proud brand has gained much traction and attention. This can also be used as an external marketing tool. If potential member's see the pride of membership current members then they will be that much more inclined to inquire about joining themselves. Because of the success of Elks Proud, the Market ing Committee plans to continue to use it whenever appropriate.

CLOSING

In closing I would like to remind people that the national Marketing Committee is always open to new ideas or suggestions so don't be afraid to drop us a line.

I would like to thank the Grand Executive for the opportunity to serve on this Committee. I would like to say a special thanks to our Marketing Co-ordinator Ryan O'Connor. Ryan's great talents and hard work makes our jobs much easier, it is appreciated.

Finally, a huge thank you to the members of our Marketing Committee. The volunteer time that you folks put in certainly goes above and beyond, we would be lost without people like you.

No suggestions for changes to our ritual or concerns were brought to my attention this year. This suggests that the membership is comfortable with our ritual.

Over the last number of years, there has been a gradual drift towards less and less ritual in the Order. With that, I have no issue. It is up to each Lodge to determine the ritual level appropriate for their membership. What I do have an issue with is that it is a drift as opposed to a thoughtful decision. It is simply easier not to do it, so we tend to do it less and less. It is a human sort of thing.

Change is always a two-sided sword – there are gains and losses. I believe that we need to discuss what it is that we lose when we give up ritual as well as what we gain. The discussion must also include how we can replace what we have lost by giving up ritual with other ways of doing things. This is not about trying to get ritual back as much as a thoughtful discussion about gains, losses and ways to overcome those losses. In other words, a well-balanced approach that does not come down on either side of the argument. The discussion needs to include some of the observations from the inter generation research as well as information from research on what it is that Canadians want from their volunteer experience.

3. PROGRAMS OF THE FUND:

PERSONAL ASSISTANCE PROGRAM

In 2018-19, approximately 50 applications were received with approximately \$120,000.00 spent on personal assistance cases.

CLINICAL PROGRAMS

\$129,000.00 was spent on the five (5) ongoing Clinical Programs.

SCHOLARSHIPS

Elks of Canada Scholarships are funded through their national charity -- The Elks & Royal Purple Fund for Children. The scholarships are administered by Speech-Language and Audiology Canada (SAC). Scholarships are available to students enrolled in a Master's Program in Speech-Language Pathology or Audiology. Thirteen scholarships (for a total of \$16,000) were awarded this year to worthy recipients selected by the SAC Scholarship Committee which includes a member of the National Charities Committee.






SECTION 11 – CONFLICTS OF INTEREST AND STANDARDS OF CONDUCT (pgs 57-59)

- 1. RATIONALE: The Grand Executive, members of Grand Lodge Committees, and the Executive Director (herein after referred to as the EXECUTIVE GROUP), have a fiduciary obligation to maintain ethical behaviour during the course of their affiliation with the Elks of Canada and are bound to act honestly, in good faith, and at all times in the best interests of the Elks of Canada and its membership. The Executive Group of the Elks of Canada is ultimately responsible for the creation of a culture which will permeate the organization and its membership. A strong ethically grounded Elks of Canada is only possible when it is governed by a strong ethical National Executive body; in turn, the strength of the National Executive body is grounded in the ethical conduct and approach of each of its Grand Executive members, its Grand Lodge Committee members, and its Executive Director.
- 1. **Standards of Conduct:** The standards of conduct for the Executive Group are based on the governing ethical principles of honesty, benevolence, non-malfeasance, justice, and equity. Recognizing the position of trust in which the membership have placed them, the members of the Executive Group must adhere at all times to the governing principles in all their decision making and recommendations pertaining to any business of the Order. The Mission Statement of the Order, the Vision Statement of the Order, and the direction of the members expressed at a National Convention, provide the **DIRECTION** in which the Executive Group carry out their leadership responsibilities. The Act of Incorporation, and National Bylaws provide the **RULES** under which the Executive Group shall operate.
- 2. **Conflict of Interest:** A conflict of interest is a situation in which an Executive Group member has, in relation to a matter coming before the Elks of Canada, a private or personal interest, sufficient to influence or appear to influence the objective, and open minded, loyal exercise of his or her function as an Executive Group member.

The circumstance giving rise to a conflict of interest need not be that of the individual Executive Group member but may be the interest of a person having close family ties to the Executive Group member, a friend, business associate, or colleague of the Executive Group member. There are basically two situations giving rise to a conflict of interest. One is that of financial interest, and the other sometimes not so obvious, is the Executive Group member who through a Grand Executive, committee, or staff position, or on account of some other significant involvement, in another corporation or organization has an obligation of loyalty that conflicts, or appears to conflict with his or her required loyalty to the Elks of Canada.

Each Executive Group member is under an obligation to avoid, whenever reasonably possible, a conflict of interest. However, conflicts of interest may nevertheless arise. In such situations the Executive Group member is required to declare the conflict of interest and refrain from voting on the issue in question. He or she is also required by these guidelines to absent himself or herself from the meeting at any time discussions of the matter giving rise to the conflict occurs. In circumstances of conflict of interest, besides declaring a conflict and absenting himself or herself from the meeting and not voting on the issue, an Executive Group member will be expected not to lobby or otherwise participate in the decision making process.

Executive Group members shall not allow their loyalty to the Elks of Canada to be compromised by their relationship to or involvement in another organization or corporation. In this regard, the Elks of Canada structure is composed of Lodges and other Chartered Units collectively known as the Grand Lodge of the Elks of Canada and each Executive Group member is required, in order to satisfy membership requirements, to be a member of a Lodge of the Elks of Canada. The fact an Executive Group member owes a duty of loyalty to his or her home Lodge or other sanctioned Unit of the Order by virtue of his or her membership, that in itself is not considered to be a conflict of interest. It is therefore not a conflict of interest for the Executive Group member to have in mind the interests of his or her Lodge when considering a matter before the Executive Group, provided always that the Executive Group member keeps an open mind, and is left free to exercise and DOES exercise his or her judgement, take a position, or cast a vote, that he or she believes to be in the BEST INTEREST OF THE ELKS OF CANADA.

3. **Acknowledgement**: Each member of the Executive Group shall be required, as a condition of their appointment, to sign the following undertaking:

I have read and understand the Order's Regulations concerning Conflict of Interest and Standards of Conduct. I promise to always act in accordance with them and as well the code of conduct expected of all Elk members as provided for in the National Constitution, Bylaws, and Regulations, and the Rituals of the Order.



Independent Auditor's Report

To the Grand Exalted Ruler and Members of The Grand Lodge of the Benevolent and Protective Order of Elks of Canada

Qualified Opinion

We have audited the financial statements of The Grand Lodge of the Benevolent and Protective Order of Elks of Canada (the "Grand Lodge"), which comprise the balance sheet as at April 30, 2019, and the statements of revenues and expenses, changes in net assets and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies (collectively referred to as the "financial statements").

In our opinion, except for the possible effects of the matters described in the *Basis for Qualified Opinion* section of this report, the accompanying financial statements present fairly, in all material respects, the financial position of the Grand Lodge as at April 30, 2019, and the results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

Basis for Qualified Opinion

As outlined in Note 2, the Grand Lodge does not amortize the cost of the building and does not capitalize certain subsequent betterments. In this respect, these financial statements are not in accordance with Canadian accounting standards for not-for-profit organizations. If amortization expense was recorded on the original cost of the building and on subsequent additions and the cost of such additions were capitalized and not expensed, amortization expense for the year would have increased by \$17,529 (2018 - \$12,593), repairs and maintenance expenses would have decreased by \$nil (2018 - \$17,064), the deficiency of revenues over expenses for the year would have increased by \$17,529 (2018 - \$4,471) and net assets at year end would have decreased by \$279,766 (2018 - \$262,237). Our audit opinion on the financial statements for the year ended April 30, 2018 was modified because of the effects of this departure from Canadian accounting standards for not-for-profit organizations.

In common with many not-for-profit organizations, the Grand Lodge derives revenue from membership fees, donations and fundraising activities, the completeness of which is not susceptible to satisfactory audit verification. Accordingly, our verification of these revenues was limited to the amounts recorded in the records of the Grand Lodge and we were not able to determine whether any adjustments might be necessary to fundraising revenue, the deficiency of revenues over expenses, and cash flows from operations for the years ended April 30, 2018 and 2019, current assets as at April 30, 2018 and 2019, and net assets as at May 1 and April 30 for both the 2018 and 2019 years. Our audit opinion on the financial statements for the year ended April 30, 2018 was modified accordingly because of the possible effects of this scope limitation.

We conducted our audit in accordance with Canadian generally accepted auditing standards ("Canadian GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities* for the *Audit of the Financial Statements* section of our report. We are independent of the Grand Lodge in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Grand Lodge's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Grand Lodge or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Grand Lodge's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian GAAS will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with Canadian GAAS, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud
 or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that
 is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material
 misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve
 collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that
 are appropriate in the circumstances, but not for the purpose of expressing an opinion on the
 effectiveness of the Grand Lodge's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Grand Lodge's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Grand Lodge to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

NOTES TO THE FINANCIAL STATEMENTS YEAR ENDED APRIL 30, 2019

1. THE ORGANIZATION

The Grand Lodge of the Benevolent and Protective Order of Elks of Canada (the "Organization" or "Grand Lodge") is a national, fraternal and charitable organization, promoting and serving community needs through volunteer efforts of local Lodges. This not-for-profit organization was incorporated in 1913 by a Special Act of Parliament and is not subject to income tax under the Income Tax Act.

2. SIGNIFICANT ACCOUNTING POLICIES

The Organization's accounting policies and its standards of financial disclosure are in accordance with Canadian accounting standards for not-for-profit organizations, except for the Organization's policies for capital assets, as explained in note 2e.

a) Basis of Presentation

These financial statements reflect only those financial activities conducted by the Grand Lodge. These financial statements do not reflect the assets, liabilities, revenues and expenses of its constituent lodges and its affiliated entities.

b) Use of Estimates

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and use assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the year. Actual results could differ from those estimations. The Organization estimates an allowance for doubtful accounts and also estimates the fair value of financial instruments.

c) Fund Accounting

The Constitution and By-laws of the Benevolent and Protective Order of Elks of Canada prescribe that the funds of the Grand Lodge shall include the General Fund, the Reserve Fund and the Elks & Royal Purple Fund for Children.

The purpose of the General Fund is to carry out the general administration and payment of general expenses of the Grand Lodge. It is to invest cash balances that are not required for the day-to-day operations of the Grand Lodge.

The internally restricted net assets consist of Reserve Funds specifically set aside by the Grand Lodge to finance some part of the Organization.

The Elks & Royal Purple Fund for Children (the "Committee") may provide financial assistance for any purpose that is:

- a) for the good and welfare of a person prior to attaining their nineteenth birthday resident in Canada, which has been approved as an appropriate purpose by the Committee, or;
- b) for other charitable programs or services provided for and approved in the annual operating budget.

The accompanying financial statements disclose the financial position and the operations of these funds administered by Grand Lodge on a restricted fund accounting basis.

NOTES TO THE FINANCIAL STATEMENTS YEAR ENDED APRIL 30, 2019

2. SIGNIFICANT ACCOUNTING POLICIES (Continued)

d) Inventory of Supplies

Supplies are valued at the lower of cost and net realizable value, with cost determined on an average cost basis.

e) Capital Assets

The Grand Lodge's approved accounting policy is to record the office building located at 2629-29th Avenue, Regina, Saskatchewan at its original cost of \$890,000 and to expense certain subsequent expenditures on renovations, additions or major repairs as incurred.

The cost of the building is not being amortized.

f) Personal Assistance Programs

Commitments to provide funding are recognized as an expense of the Elks & Royal Purple Fund for Children when the National Sub-Assistance Committee approves the funding.

h) Revenue Recognition

Membership fees are recorded as revenue over the applicable membership period when they can be measured and collectability is assured. Membership fees received in advance are recorded as deferred revenue and recognized into revenue during the appropriate period.

Deferred revenue at April 30, 2019 relate to the membership year January 1, 2019 to December 31, 2019.

i) Employee Benefits

The Grand Lodge contributes 5% of basic salary into the employee's individual RRSP plans. Under the RRSP plan, the Grand Lodge's obligations are limited to making required contributions. The Grand Lodge also funds an employee life insurance and health insurance plan by covering a portion of the premiums exclusive of premiums for long-term disability coverage. These contributions and premiums are expensed in the period in which they are made.

j) Financial Instruments

The Grand Lodge initially measures its financial assets and financial liabilities at fair value. The Grand Lodge subsequently measures all its financial assets and financial liabilities at amortized cost, except for investments that are quoted in an active market (short-term investments, pooled funds, equities, and mutual funds) which are measured at fair value. Changes in fair value are recognized in the statement of revenues and expenses.

Transaction costs related to financial instruments measured subsequent to initial recognition at fair value are expensed as incurred.

NOTES TO THE FINANCIAL STATEMENTS YEAR ENDED APRIL 30, 2019

2. SIGNIFICANT ACCOUNTING POLICIES (Continued)

Transaction costs related to other financial instruments are added to the carrying value of the asset or netted against the carrying value of the liability and are then recognized using the effective interest method. Any premium or discount related to an instrument measured at amortized cost is amortized over the expected life using the effective interest method and recognized in the statement of revenues and expenses as interest income or expense.

With respect to financial assets measured at cost or amortized cost, the Grand Lodge recognizes in the statement of revenues and expenses an impairment loss, if any, when it determines that a significant adverse change has occurred during the period in the expected timing or amount of future cash flows. When the extent of impairment of a previously written-down asset decreases and the decrease can be related to an event occurring after the impairment was recognized, the previously recognized impairment loss shall be reversed in the statement of revenues and expenses in the period the reversal occurs.

Foreign Exchange Risk – The Grand Lodge is exposed to foreign exchange risk due to investments in U.S. and International equities. The Grand Lodge does not use derivative instruments to mitigate its exposure to foreign currency risk.

Interest Rate Risk – Interest rate risk refers to the adverse consequences of interest rate changes on the Grand Lodge's cash flows, financial position and income. Certain of the Grand Lodge's investments bear interest at fixed rates. Consequently, the cash flow exposure is not significant. However, the fair value of investments having fixed rates of interest could fluctuate because of changes in market interest rates.

The Organization is also exposed to interest rate risk in respect of the fair value of its fixed rate long-term debt.

Price Risk – Price risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. The Grand Lodge is exposed to price risk through its investments in pooled funds and equities for which the value fluctuates with the quoted market price.

Credit Risk – The Grand Lodge's principal financial assets are cash, investments and accounts receivable, which are subject to credit risk. The carrying amounts of financial assets on the statement of financial position represent the Grand Lodge's maximum credit exposure at the balance sheet date.

The Grand Lodge's credit risk is primarily attributable to its trade receivables. The amounts disclosed in the balance sheet are net of allowance for doubtful accounts, estimated by the management of the Grand Lodge based on previous experience and its assessment of the current economic environment. The Grand Lodge does not have significant exposure to any individual customer. The Grand Lodge also limits its exposure by ensuring that it has invested in a diversified portfolio and that there is no large exposure to any one issuer.

Liquidity Risk – The Liquidity risk is the risk of being unable to meet cash requirements or to fund obligations as they become due.

The Grand Lodge manages its liquidity risk by constantly monitoring forecasted and actual cash flows and financial liability maturities, and by holding assets that can be readily converted into cash.

Accounts payable are generally repaid within 30 days.

6. SUSPENDED LODGE TRUST FUNDS

The Constitution and Bylaws of the Grand Lodge provide that when a subordinate Lodge surrenders its Charter, Grand Lodge assumes its assets in trust. In the event of a Subordinate Lodge being reorganized within five years, all assets held in trust shall be restored to the Subordinate Lodge. If the Subordinate Lodge is not reorganized within five years, all such assets shall be transferred to the Elks & Royal Purple Fund for Children or directly to a charity in the community in which the Lodge was located, if such a request is made by members of the Lodge at the time of dissolution. There was \$4,697 in trust funds held on April 30, 2019 (2018 – \$4,697).

a) Contingency Reserves:

The General Fund Contingency Reserve has been established to meet one year's operating costs and is administered under the direction of the Audit/Finance Committee. Effective April 30, 2019, no additional funds were required to be transferred to the reserve as per Article 2 Section 5.2.1 of the Grand Lodge Bylaws.

The National Charities Committee has established, upon the recommendation of the Grand Lodge Audit/Finance Committee, a Contingency Reserve for the Elks and Royal Purple Fund for Children which by policy will be adjusted annually to equate to one year's operating expenses. Effective April 30, 2019, no additional funds were required to be transferred to the reserve and approved by Grand Executive.

b) National Sports Reserve:

This reserve will remain in effect to receive future funding from funds accumulated from national sports events and it is proposed that the reserve will be used to fund future sports projects. Effective April 30, 2019, \$235 was transferred to the reserve from the unrestricted funds, as per Article 2 Section 5.3.1 of the Grand Lodge Bylaws.

c) Employee Benefit Reserve:

This reserve was established to fund future benefit payments and exceptional costs arising from time to time for current and future employees. The reserve is administered by the Grand Executive in accordance with their policies as determined from time to time. Effective April 30, 2019, no additional funds were required to be transferred to the reserve as per Article 2 Section 5.2.1 of the Grand Lodge Bylaws.

d) Elks Memorial Building Fund Reserve:

This reserve is comprised of amounts bequeathed, donated or contributed by members of the Elks, Royal Purple, or any other interested parties. The Reserve is administered by the Grand Executive of the Elks of Canada, and shall be used exclusively towards the enhancement of the Elks National Building in accordance with Article 2 Section 5.2.1 of the Grand Lodge Bylaws. Effective April 30, 2019, no additional funds were required to be transferred to the reserve.

NOTES TO THE FINANCIAL STATEMENTS YEAR ENDED APRIL 30, 2019

8. INTERNALLY RESTRICTED FUNDS (Continued)

e) Facility Contingency Reserve:

This reserve has been established from funds accumulated from net lease revenues and will be utilized for replacement or major repair or renovation of any part of the building or building service equipment. Effective April 30, 2019, \$15,000 was transferred from the unrestricted funds to the reserve, as per policies established and approved by the Grand Executive. Also, effective April 30, 2019, \$35,000 was transferred from the reserve to the unrestricted funds to reflect recent major repairs and betterments of the building as approved by the Grand Executive.

f) National Curling Reserve:

This reserve has been established under the direction of the Grand Executive to provide for on-going promotion of National Curling administered by the newly established National Curling Committee under the direction of the National Sports Committee. Effective April 30, 2019, \$1,520 was transferred to the reserve from the unrestricted funds, as per Article 2 Section 5.3.1 of the Grand Lodge Bylaws.

g) Legacy Reserve:

This reserve has been established under the direction of the Grand Executive to provide for on-going promotion of the Elks of Canada. Effective April 30, 2019, no additional funds were required to be transferred to the reserve as per policies established and approved by the Grand Executive.

9. CONTRACTUAL SERVICES

Under an agreement with the National Charities Committee, a sum of \$227,970 (2018 - \$223,500) was paid to the Grand Lodge as a fee for service for the provision of support and administration services provided by the Grand Lodge Office. The Grand Lodge Office provides all staff and services to carry out all charitable programs, fund raising and administrative and general support functions of the Elks & Royal Purple Fund for Children as approved by the National Charities Committee. The amount received is credited to the Grand Lodge salaries account thereby reducing the total salaries and benefits paid for the Grand Lodge to \$359,639.

11. CONTINGENCIES

In the course of their operations, Grand Lodge and its constituent Lodges and affiliated entities may become involved in legal actions including claims arising from personal injuries or property damage. While the final outcome of these claims cannot be predicted with certainty, management believes that no provision for loss is required at April 30, 2019. Management is not aware of any pending or unresolved actions at this time.

12. COMMITMENTS

The Grand Lodge is committed to payments with respect to an agreement to lease its photocopier effective May 1, 2013. Future payments required under the lease are as follows:

The Elks & Royal Purple Fund for Children is committed to the General Fund for month to month rental payments of \$2,140 plus share of common area costs. The agreement between the Funds has no fixed terms. During the year, building lease revenue totalling \$25,681 (2018 – \$25,681) was recorded by the General Fund and rent expense of \$25,681 (2018 - \$25,681) was recorded by the Elks & Royal Purple Fund for Children.

13. EMPLOYEE BENEFITS

The Grand Lodge pays funds into individual employee RRSP plans. Contributions totalling \$21,390 (2018 - \$28,113) were made to the employees' individual plans.





RESOLUTIONS

RESOLUTION NO. 1

RE: SALE OF BUILDING AND PROPERTY

WHEREAS the administration of the Elks of Canada is the responsibility of the Grand Lodge Executive, including the financial accountability to ensure the sustainability of the Elks of Canada as a Canadian Chartered Organization;

AND WHEREAS the membership of the Elks of Canada across the country has been diminishing over the past few years resulting in a severe reduction in Affiliate Fees paid to the Elks of Canada for the Administration of the organization;

AND WHEREAS the sustainability of the Elks of Canada is threatened by the insufficient revenues generated by Affiliate Fees and rental income;

AND WHEREAS the Grand Lodge Executive believes that an injection of funds could assist in sustaining the operations of the Elks of Canada with some allocation to projects which will increase membership within the Elks of Canada;

AND WHEREAS the assets of the Elks of Canada includes property and a large building located in Regina Saskatchewan, which, while aging and larger than required to house the staff of the Elks of Canada holds a retail value of approximately \$2.4 to \$2.6 M.

NOW THEREFORE, BE IT RESOLVED that the building and property held by the Elks of Canada in Regina, Saskatchewan be sold to create necessary resources to be allocated to procuring suitable office space to purchase and resources for operational and project funding.

SUBMITTED BY THE GRAND EXECUTIVE APPROVED BY THE GRAND EXECUTIVE

After hearing the discussions regarding the sale of building and property, the following motion resulted.

MOTION: SISTER DEBORAH SALLENBACK/BROTHER JERRY WERNICKE: TO postpone the Resolution on the Sale of the Building and Property until the 2020 National Convention. **CARRIED**

RE: SALE OF LODGE REAL ESTATE

WHEREAS many Elks and Royal Purple Elks Lodges are facing aging and diminishing memberships, challenging the ability of Lodges to cover the expenses of their buildings;

AND WHEREAS the high return on real estate sales is further enticing Lodges to sell their real estate, particularly where Lodges are located in high visibility and downtown locations;

AND WHEREAS there is no requirement for Lodges to advise Grand Lodge of the challenges a Lodge is facing regarding maintenance of their property or to provide notice of an intent to liquidate Lodge real estate or property;

AND WHEREAS in some circumstances Grand Lodge has been held responsible financially for title and registration issues for property of some Lodges which requires legal costs and expenses being charged to Grand Lodge and/or the Lodge directly;

AND WHEREAS anecdotal evidence indicates that the sale of Lodge buildings in some communities has diminished the public visibility of the Elks Lodges causing concern about the ability to grow or revitalize an Elks Lodge;

NOW THEREFORE BE IT RESOLVED that the Elks of Canada Regulations be amended to include:

In the event an Elks or Royal Purple Elks Lodge who owns real estate (property and/or building) is considering the voluntary surrender of their Lodge Charter and/or sale of their property they shall contact Grand Lodge in writing advising that such action is being considered.

No Elks or Royal Purple Elks Lodge real estate may be listed for sale prior to receiving written agreement from Grand Lodge of the Elks of Canada.

The Grand Lodge of the Elks of Canada shall investigate the reasons for the sale of the real estate and offer assistance to the Lodge to facilitate the sale or, if, in cooperation with the Lodge, it is determined that action can be taken to mitigate challenges, provide appropriate resources to allow for the retention of the property.

RE: INCREASE IN NATIONAL REGISTRATION/AFFILIATION FEES

WHEREAS the Grand Lodge Bylaws stipulate that National Registration/Affiliation Fees is to be levied on each Lodge based on the number of members in each Lodge;

AND WHEREAS said Regulation allows for an automatic increase in fees annually up to 5% in line with the increases in the cost of living, which is posted for 2018 as 1.33%;

AND WHEREAS Affiliate fees are the main source of operational income for Grand Lodge.;

AND WHEREAS the operational funds that are being generated by the membership and the revenue coming to Grand Lodge through the collection of leases within the building are insufficient to sustain the operational costs of Grand Lodge;

AND WHEREAS the Grand Lodge Executive has made significant reductions in the 2019-2020 proposed budget, but not enough to keep the budget being presented from being in a deficit position;

AND WHEREAS a 5% increase in Affiliate fees is projected to balance the proposed budget;

NOW THEREFORE BE IT RESOLVED THAT Affiliate fees shall be increased by 5% as of January 1st, 2020 to \$4.83 per member per month and \$3.64 per member per month for family members.

AMENDED TO READ:

NOW THEREFORE BE IT RESOLVED THAT Affiliate fees shall be increased as of January 1st, 2020 to **\$5.00 per member per month** and **\$4.00 per member per month** for family members.

RE: NOTICE OF INTENT TO SEEK OFFICE

WHEREAS the current Bylaws and Regulations stipulate that Nominations for positions on the Grand Lodge Executive are made at the National Convention and there is no process in place whereby members can know in advance of Convention that there are members who are interested in being elected to the Grand Lodge Executive to properly fill the positions;

AND WHEREAS there is no process in place that allows members and Convention delegates to know who may be nominated for positions on the Grand Lodge Executive in advance of attendance at the Grand Lodge Convention;

AND WHEREAS while there is a process in place that allows a member not present at Convention to accept a nomination made at Convention, historically nominations have been made and accepted only by members present at Convention;

AND WHEREAS there are many members who could provide executive leadership as members of the Grand Lodge Executive, but are not present at Grand Lodge Convention;

NOW THEREFORE BE IT RESOLVED THAT the Elks of Canada General Regulation 1 be amended to read:

NOMINATIONS:

- 1. Nominations shall be made separately for all elective offices in the Grand Lodge, Associations, Lodges, and any other Unit of the Order in the order in which they appear in their respective sections commencing with the most senior.
- 2. If nominations are provided for at more than one time, further nominations shall be accepted at specified times up to the calling of the actual election.

NOTICE OF INTENT TO SEEK OFFICE

- 3. Eligible members of the Order may provide Notice of Intent to Run for office not later than March 1st of the year they intend to run for elective office.
- 4. Notice of Intent to Run does not require that they designate the particular office position being sought.
- 5. Notice of Intent to Run forms shall be approved by Grand Lodge Executive for Grand Lodge Office and Association Executive for Office in Associations and its member Lodges.

CONSENT:

6. Each candidate for an elected office in the Order shall signify his/her willingness to accept the nomination, and, if elected, to serve, upon presentation of his/her name, in person if present, or, if absent, in writing to the Chairman, such written authorization being presented at the time of nomination.

CAMPAIGN SPEECHES:

7. Members who intend to run for office may provide Grand Lodge or Association, as applicable, a Statement of intent including a brief biography, a description of why they wish to run for office and/

- or information related to their perspective on how their election can benefit the membership and promote the Order.
- 8. Such statement shall be provided in writing to Grand Lodge or Association, as applicable, not later than 90 days prior to Convention or Conference.
- 9. At the discretion of Grand Lodge or Association, statements may be edited and returned to the member for final approval. Approved statements may then be published for members' information in whatever manner approved by the applicable Executive (Grand Lodge or Association).
- 10. Nominators of candidates for any office of Grand Lodge, Association, Lodge, and any other Unit of the Order, shall be permitted a nomination address not to exceed two minutes and in the case of contested elections, the candidate shall be permitted a campaign speech prior to the election, not to exceed two minutes.
 - Nominators of candidates for any office shall make their nomination and introduce the nominee to the members in an address not to exceed one minute. The Nominee will have up to five minutes to accept the nomination and address the members present.

Current General Regulation reads:

- 2. **Consent:** Each candidate for an elected office in the Order shall signify his/her willingness to accept the nomination, and, if elected, to serve, upon presentation of his/her name, in person if present, or, if absent, in writing to the Chairman, such written authorization being presented at the time of nomination.
- 3. **Campaign Speeches:** Nominators of candidates for any office of Grand Lodge, Association, Lodge, and any other Unit of the Order, shall be permitted a nomination address not to exceed two minutes and in the case of contested elections, the candidate shall be permitted a campaign speech prior to the election, not to exceed two minutes.
